**4 – First Aid Measures**

**Ingestion (Swallowed):** Aspiration Hazard. DO NOT induce vomiting. Call physician or poison control center immediately.

**Eye Contact:** Flush thoroughly with water for at least 15 minutes. Get medical attention if irritation persists.

**Skin Contact:** Wash with soap and water. If irritation develops and persists, get medical attention.

**Inhalation (Breathing):** If irritation is experienced, move to fresh air. Get medical attention if irritation or other symptoms develop and persist.

**Most Important Symptoms (acute and delayed):** May cause eye and skin irritation. Inhalation may cause drowsiness, dizziness and other nervous system effects. Aspiration of liquid into the lungs during swallowing

or vomiting may cause lung damage. N-Hexane exposure can cause peripheral neuropathies. Initial symptoms include numbness in the extremities. Motor weakness may also occur.

**Indication of Immediate Medical Attention or Special Treatment:** Immediate medical attention is required for ingestion.

#### 5 – Fire Fighting Measures

**Extinguishing Media:** Use water fog, dry chemical, carbon dioxide or foam. Do not use water jet or flooding amounts of water. Burning product will float on the surface and spread fire.

**Special Fire Fighting Procedures:** Firefighters should always wear positive pressure self-contained breathing apparatus and full protective clothing. Cool fire-exposed containers with water. Use shielding to protect against bursting containers.

**Unusual Fire and Explosion Hazards:** Extremely flammable aerosol. Contents under pressure. Keep away from ignition source and open fire. Exposure of containers to extreme heat and flames can cause them to rupture often with violent force. Vapors can cause a flash fire. Vapors are heavier than air and may travel along surfaces to remote ignition sources and flash back. A vapor and air mixture can create an explosion hazard in confined spaces.

#### 6 – Accidental Release Measures

Wear appropriate protective clothing (see Section 8). Eliminate all sources of ignition and ventilate area. Leaking cans should be placed in a plastic bag or open pail until the pressure has dissipated. Contain and collect liquid with an inert absorbent and place in a container for disposal. Clean spill area thoroughly. Report spills to authorities as required.

#### 7 – Handling and Storage

**Handling:** Avoid contact with eyes. Avoid prolonged contact with skin. Avoid breathing vapors or aerosols. Use only with adequate ventilation. Keep away from heat, sparks, pilot lights, hot surfaces and open flames. Unplug electrical tools, motors and appliances before spraying or bringing the can near any source of electricity. Electricity can burn a hole in the can and cause contents to burst into flames. To avoid serious burn injury, do not let the can touch battery terminals, electrical connections on motors or appliances or any other source of electricity. Wash thoroughly with soap and water after handling. Keep containers closed when not in use. Keep out of the reach of children. Do not puncture, crush or incinerate containers, even when empty.

**Storage:** Do not store above 120°F or in direct sunlight. U.F.C (NFPA 30B) Level 3 Aerosol.

#### The Following Controls are Recommended for Normal Consumer Use of this Product

**Engineering Controls:** Use in a well-ventilated area.

#### Personal Protection:

**Eye Protection:** Avoid eye contact. Always spray away from your face.

**Skin Protection:** Avoid prolonged skin contact. Chemical resistant gloves recommended for operations where skin contact is likely.

**Respiratory Protection:** None needed for normal use with adequate ventilation.

#### For Bulk Processing or Workplace Use the Following Controls are Recommended

**Engineering Controls:** Use adequate general and local exhaust ventilation to maintain exposure levels below that occupational exposure limits.

**10 – Stability and Reactivity**

**Stability:** Stable

**Hazardous Polymerization:** Will not occur.

**Conditions to Avoid:** Avoid heat, sparks, flames and other sources of ignition. Do not puncture or incinerate containers.

**Incompatibilities:** Strong oxidizing and reducing agents.

**Hazardous Decomposition Products:** Carbon monoxide and carbon dioxide.

**11 – Toxicological Information**

**Symptoms of Overexposure:**

**Inhalation:** High concentrations may cause nasal and respiratory irritation and central nervous system effects such as headache, dizziness, drowsiness, loss of coordination and nausea. Intentional abuse may be harmful or fatal.

**Skin Contact:** Causes skin irritation. Prolonged and/or repeated contact may produce drying and defatting with possible dermatitis.

**Eye Contact:** Contact may be mildly irritating to eyes. May cause redness and tearing.

**Ingestion:** This product has low oral toxicity. Swallowing may cause gastrointestinal irritation, nausea, vomiting and diarrhea. The liquid contents are an aspiration hazard. If swallowed, can enter the lungs and may cause chemical pneumonitis.

**Chronic Effects:** Prolonged overexposure may cause nervous system damage. N-Hexane exposure can cause peripheral neuropathies. Initial symptoms include numbness in the extremities. Motor weakness may also occur. Prolonged exposure to n-hexane has resulted in decreased sperm count and degenerative changes in the testes of rats but not mice.

**Medical Conditions Aggravated by Exposure:** Preexisting eye, skin and respiratory conditions may be aggravated by exposure.
